JUDGING: Dancers will be judged according to the Rules and Regulations of the S.O.B.H.D. Judges' decision is final. No access to the judges' sheets. In the event of a protest, a \$20.00 fee must accompany a written complaint and be submitted by midnight on the date of the competition.

PRIZES: Medals and trophies will be awarded in all categories except Primary. Age groups will be based on the number of entries. Gift bags will be awarded to all primary and the youngest group of beginner dancers in addition to medal awards.

Category changes may be phoned in to **Kaitlyn Munn @ 1-506-654-0795**. No collect calls please. Dancer numbers are to be picked up at the registration table upon verification of ScotDance card. Entries will not be accepted without a valid 2017 ScotDance card. Awards will be withheld without a current SOBHD dancer registration card and a penalty of \$5.00 charged. Dancers must be in full costume, including ghillies and hornpipe hats, to receive their awards.

The **Forever Highland Dance Association** will not be responsible for any injuries, accidents or lost articles to competitors or spectators.

There will be a full canteen available.

Competition Rules

1. Competitors are to hold and present a current SOBHD registration card or award to be withheld until proof of registration.
2. All events will be run according to the rules and regulations of the SOBHD.
3. Deadline for status changes is September 20st, 2017. Please email kaitlyn.munn@hotmail.com
4. Decision of the judge will be final. No persons other then members of the competition committee shall communicate with the judge.
5. Complaints must be in written form, signed, accompanied by 25.00 and submitted to the competition organizer before the end of the competition. The fee will be refunded if the complaint is sustained.
6. Dancers must be in full dress including slippers to receive awards.
7. Numbers to be picked up at the registration table and late entries may not appear in the program.
8. Dancers must report promptly to line up area when called or risk disqualification.
9. Absolutely no parents, teachers or coaching in the line-up area.
